2. - 6. VECC has obtained a copy of the main Application from the Board's website. However, it was unable to obtain copies of either the ERA model referenced at Exhibit 1/Tab 1/Schedule 3 or the supplementary materials filed on September 25, 2009. VECC requests that copies of these and any additional materials be forwarded to each of the two parties named above.
- 7. VECC is intervening in order to ensure that consumer interests and in particular the interests of the low-income and vulnerable users of electricity are fully represented in the determination of just and reasonable rates for 2010. Areas of the current Application of interest to VECC include: a) the proposed increase in distribution rates of over 20%, b) the more than 10% increase in rate base since 2008, c) the 31% increase in OM&A costs since 2007; d) the load forecast methodology, e) the

allocation of costs to customer classes, f) the proposed rate design for

residential customers, and g) the smart meter rate adder request.

8. VECC agrees with the Board's proposal to deal with the application by

way of a written proceeding, with the provision for an oral component if

required. In VECC's view, the decision regarding the need for an oral

component is best made after the completion of the interrogatory process.

9. VECC will be requesting an award of costs for its participation in this

proceeding and believes that, as a coalition representing the direct

interests of consumers, it meets the eligibility criteria set out in the Ontario

Energy Board's Rules of Practice and Procedure (Section 41) and its'

Practice Direction on Cost Awards (Section 3.03).
