The following applicants have applied to the Ontario Energy Board for electricity generation licences under the Standard Offer Program.

The granting of these licences would enable the applicants to generate electricity in Ontario. The applications include proposed solar generation facilities with an installed capacity of 9 MW and 10 MW respectively and are located on Part Lot 20, Concession 4 Fitzroy in West Carleton (now City of Ottawa), Ontario.

The applications will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. The employee does not intend to provide for an award of costs when deciding this application.

How to participate in the hearing

The applications will be decided by way of written hearings unless a party satisfies the Board that there is good reason for holding oral hearings. If you object to a written hearing for any of these applications, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant by October 26, 2009.

If you wish to participate in a written hearing, you must forward three paper copies, and if possible, an electronic copy in Word format and searchable PDF format, of your

written submission on the applications, to the Board and one copy to the applicants. All submissions must be received by October 28, 2009. If the applicants wish to respond to the written submissions, such response must be filed with the Board and copied to any party that made submissions by November 4, 2009.

All submissions must quote file numbers EB-2009-0357 and EB-2009-0358 and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
