IN THE MATTER OF the *Ontario Energy Board Act 1998*, S.O.1998, c.15, (Schedule B);

AND IN THE MATTER OF an Application by Union Gas Limited for an Order or Orders approving or fixing just and reasonable rates and other charges for the sale, distribution, transmission and storage of gas effective January 1, 2010.

PROCEDURAL ORDER NO. 2

Union Gas Distribution Inc. ("Union" or "Applicant") filed an Application on September 3, 2009 with the Ontario Energy Board (the "Board") under section 36 of the *Ontario Energy Board Act, 1998*, S.O. c.15, Sched. B, as amended, for an order of the Board approving or fixing rates for the distribution, transmission and storage of natural gas, effective January 1, 2010. The Board assigned file number EB-2009-0275 to the Application and issued a Notice of Application dated September 10, 2009.

Pursuant to Procedural Order No. 1 issued on October 6, 2009, a settlement conference was held on October 28, 2009, attended by Union and the intervenors. The parties reached a settlement on all issues and Union filed a Settlement Agreement with the Board on November 2, 2009. The parties agreed that subject to the Board determining otherwise, the oral presentation of the Settlement Agreement scheduled to be held on November 6, 2009 was not necessary.

The Board has determined that it will not require an oral presentation of the Settlement Proposal.

Please be aware that further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

1. The oral hearing scheduled for **Friday November 6, 2009** to review the Settlement Proposal is cancelled.
