**NOTICE OF APPLICATION AND WRITTEN HEARING FOR AN
ELECTRICITY DISTRIBUTION RATE CHANGE**

Lakefront Utilities Inc.

The Ontario Energy Board (the "Board") received an application on October 20, 2009, under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15 (Schedule B), seeking approval for changes to the rates that Lakefront Utilities Inc. ("Lakefront") charges for electricity distribution, to be effective May 1, 2010. The Board has assigned the application file number EB-2009-0233. The Board's decision on this application may have an effect on all of Lakefront's customers. The application was filed under the Board's guidelines for 3rd Generation Incentive Regulation, which provides for a mechanistic and formulaic adjustment to rates between cost of service applications.

Any change to the rates that Lakefront charges for electricity distribution will be reflected in the delivery charges. Delivery charges are one of four regular items on residential and general service customers' electricity bills and vary depending on the amount of electricity consumed.

Lakefront indicates that if the application is approved as filed, a residential customer consuming 800 kWh per month would experience an approximate 6.8% increase in delivery charges. This is a \$2.07 per month increase on the total bill. A small general service customer consuming 2,000 kWh per month and having a monthly demand of 50 kW or lower would experience an approximate 1.8% increase in delivery charges. This is a \$1.21 per month increase on the total bill.

How to see Lakefront's Application

Copies of the application are available for inspection at the Board's office in Toronto and on its website, www.oeb.gov.on.ca, and at Lakefront's office and may be on its website.

How to Participate in the Rate Proceeding

The Board intends to proceed with this specific application by way of a written hearing, unless a party satisfies the Board that there is good reason to proceed instead with an oral hearing.

You may participate in this proceeding in one of two ways set out below. Anyone who wishes to follow the proceeding without participating can review most documents relevant to the proceeding through the Board's website.

1. Send a letter of comment to the Board

You may file a letter with your comments with the Board and Lakefront. Your letter of comment will be provided to the Board panel deciding the application, and will be part of the public record. Your letter of comment must be received no later than **December 4, 2009**. The Board accepts letters of comment by either post or e-mail at the addresses below.

2. Become an Intervenor

You may ask to become an intervenor if you wish to actively participate in the proceeding. You must also provide a copy of your letter of intervention to Lakefront. Intervenor status is eligible to receive evidence and other material submitted by participants in the hearing. Likewise, intervenors will be expected to send copies of any material they file to all parties to the hearing. Your request for intervenor status must be made by letter of intervention and be received by the Board no later than **December 4, 2009**. Your letter of intervention must include a description of how you are, or may be, affected by the outcome of this proceeding; and if you represent a group, a description of the group and its membership. The Board may order costs in this proceeding only in relation to Lakefront's proposal for a revenue cost ratio adjustment. You must indicate in your letter of intervention whether you expect to seek costs from Lakefront and the grounds for your eligibility for costs. For more information on cost awards and costs

Interrogatories and Submissions

Board-approved intervenors who wish information and material from Lakefront that is in addition to the evidence filed with the Board and that is relevant to the hearing shall request it by written interrogatories filed with the Board and delivered to Lakefront on or before **December 10, 2009**. Lakefront shall file with the Board complete responses to the interrogatories and deliver them to all intervenors no later than **January 6, 2010**.

Written submissions by an intervenor may be filed with the Board, and if so must be delivered to Lakefront and other intervenors, by **January 27, 2010**. If Lakefront wishes to respond to the submissions, its written response must be filed with the Board and delivered to all intervenors by **February 17, 2010**.

How to File Documents with the Board

If you already have a user ID, please submit your interrogatories or submission through the Board's web portal at www.errr.oeb.gov.on.ca. Additionally, two paper copies are required. If you do not have a user ID, please visit the Board's website under e-filings and fill out a user ID password request. Those who do not have internet access are asked to submit their interrogatories or submission on a CD or diskette in PDF format, along with two paper copies. You may also send your submission by post or e-mail to the addresses below.

In responding to this Notice, please include Board file number EB-2009-0233 in the subject line of your e-mail or at the top of your document. It is also important that you provide your name, postal address and telephone number and, if available, an e-mail address and fax number. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
