- 3) If Welland Hydro-Electric System Corp. is a host distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its embedded distributor(s);
- 4) To file with the Board an affidavit proving publication and, where applicable, service of the Notice immediately thereafter.
 - The affidavit must be sworn by a commissioner of oaths which include, among others, a lawyer, a paralegal, some law clerks, and a student at law;
