# NOTICE OF APPLICATION AND WRITTEN HEARING FOR AN ELECTRICITY DISTRIBUTION RATE CHANGE

## **Hydro Ottawa Limited**

The Ontario Energy Board (the "Board") received an application on October 21, 2009, under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15 (Schedule B), seeking approval for changes to the rates that Hydro Ottawa Limited ("Hydro Ottawa") charges for electricity distribution, to be effective May 1, 2010. The Board has assigned the application file number EB-2009-0231. The Board's decision on this application may have an effect on all of Hydro Ottawa's customers. The application was filed under the Board's guidelines for 3rd Generation Incentive Regulation, which provides for a mechanistic and formulaic adjustment to rates between cost of service applications.

Any change to the rates that Hydro Ottawa charges for electricity distribution will be reflected in the delivery charges. Delivery charges are one of four regular items on residential and general service customers' electricity bills and vary depending on the amount of electricity consumed.

Hydro Ottawa indicates that if the application is approved as filed, a residential customer consuming 800 kWh per month would experience an approximate 0.4% decrease in delivery charges. This is a \$0.15 per month decrease on the total bill. A small general service customer consuming 2,000 kWh per month and having a monthly demand of 50 kW or lower would experience an approximate 0.5% increase in delivery charges. This is a \$0.40 per month increase on the total bill.

# **How to see Hydro Ottawa's Application**

Copies of the application are available for inspection at the Board's office in Toronto and on its website, www.oeb.gov.on.ca, and at Hydro Ottawa's office and may be on its website.

## **How to Participate in the Rate Proceeding**

The Board intends to proceed with this specific application by way of a written hearing, unless a party satisfies the Board that there is good reason to proceed instead with an oral hearing.

You may participate in this proceeding in one of two ways set out below. Anyone who wishes to follow the proceeding without participating can review most documents relevant to the proceeding through the Board's website.

#### 1. Send a letter of comment to the Board

You may file a letter with your comments with the Board and Hydro Ottawa. Your letter of comment will be provided to the Board panel deciding the application, and will be part of the public record. Your letter of comment must be received no later than **December 4**, **2009**. The Board accepts letter of comment by either post or e-mail at the addresses below.

#### 2. Become an Intervenor

You must also provide a copy of your letter of intervention to Hydro Ottawa. Intervenors are eligible to receive evidence and other material submitted by participants in the hearing. Likewise, intervenors will be expected to send copies of any material they file to all parties to the hearing. Your request for intervenor status must be made by letter of intervention and be received by the Board no later than **December 9, 2009**. Your letter of intervention must include a description of how you are, or may be, affected by the outcome of this proceeding; and if you represent a group, a description of the group and its membership. The Board may order costs in this proceeding only in relation to Hydro Ottawa's proposal for a Lost Revenue Adjustment Mechanism (LRAM) Recovery/Shared Savings Mechanism (SSM) Recovery. You must indicate in your letter of intervention whether you expect to

seek costs from Hydro Ottawa and the grounds for your eligibility for costs. For more information on cost awards and costs eligibility, please see the Board's *Practice Direction on Cost Awards*, available on the Board's website.

# **Interrogatories and Submissions**

Board-approved intervenors who wish information and material from Hydro Ottawa that is in addition to the evidence filed with the Board and that is relevant to the hearing shall request it by written interrogatories filed with the Board and delivered to Hydro Ottawa on or before **December 15, 2009**. Hydro Ottawa shall file with the Board complete responses to the interrogatories and deliver them to all intervenors no later than **January 11, 2010**.

Written submissions by an intervenor may be filed with the Board, and if so must be delivered to Hydro Ottawa and other intervenors, by **February 1, 2010**. If Hydro Ottawa wishes to respond to the submissions, its written response must be filed with the Board and delivered to all intervenors by **February 22, 2010**.

## **How to File Documents with the Board**
