DECISION AND ORDER

Enbridge Ontario Wind Power L.P. ("Enbridge") and Sarnia Solar Farm No. 2 L.P. ("Sarnia") filed a joint application under section 74 of the *Ontario Energy Board Act, 1998*, for an order of the Board to amend their electricity generation licences EG-2006-0009 and EG-2009-0016, respectively to reflect changes to the list of facilities on Schedule 1. The application was received by the Board on October 28, 2009.

On November 9, 2009, the applicants filed additional information to support the changes proposed in their application.

Enbridge intends to purchase two solar generation facilities with contracts under the Renewable Energy Standard Offer Program from Sarnia. The names and locations of the facilities to be purchased are as follows:

- Sarnia Solar 2, generation facility, owned and operated by the Licensee at Concession 3, Pt Lots 14 and 15, Sarnia, Ontario; and
- Sarnia Solar 5, generation facility, owned and operated by the Licensee at Concession 3, Pt Lots 14 and 15, Sarnia, Ontario.

The applicants have requested an amendment of Schedule 1 of their respective generation licences to reflect the proposed transaction.

Sarnia has also requested that the Board amend the concession and the lot number on which the facilities to be transferred are located. The amended property description is reflected in the description of the facilities above.

I have proceeded without a hearing pursuant to section 21(4)(b) of the Act since no other parties are adversely affected in a material way by the outcome of the proceeding and the applicants have requested that the matter be disposed of without a hearing.

I find that the information provided in the application is sufficient to demonstrate that granting the requested amendments is in the public interest. Enbridge is presently licensed as an electricity generator and authorized to own and operate the wind power substation in Kincardine, Ontario. No negative consequences to the transaction have been identified.

The amended licences will be issued when the Board receives confirmation from the applicants that the commercial transaction has closed, and will be effective from the date of closing.

IT IS ORDERED THAT:

1. Schedule 1 of Enbridge Ontario Wind Power L.P.'s electricity generation licence EG-2006-0009 will be amended as requested to add the names and locations of the two generation facilities, reflecting the amended property description.
2. Schedule 1 of Sarnia Solar Farm No. 2 L.P.'s electricity generation licence EG-2009-0016 will be amended to remove the two generation facilities from the licence.
