NOTICE OF APPLICATION

APPLICATION TO AMEND THE DISTRIBUTION SERVICE AREA OF BRANT COUNTY POWER INC.

Brant County Power Inc. ("Brant County") filed an application with the Ontario Energy Board under the *Ontario Energy Board Act, 1998,* S.O. 1998, c. 15, Schedule B, for an order of the Board amending Brant County's distribution service area.

The Board has assigned file number EB-2009-0391 to the application. The application will be decided by the Counsel, Special Projects who has been delegated this authority pursuant to section 6 of the Act.

Service Area Amendment

The proposed service area amendment will eliminate a load transfer arrangement between Brant County and Hydro One Networks by transferring one general service customer from Hydro One Networks to Brant County. The customer is a school that wishes to upgrade from a single phase to a three phase service.

The proposed amendment will alter the service area as described in Schedule 1 of Brant County's electricity distribution licence.

How to Participate in the Proceeding

The application will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any objections to a written hearing must be received by the Board and copied to the applicant within 10 days of the date this notice was served. The Counsel, Special Projects does not intend to provide for an award of costs when deciding this application.

If you wish to participate in the written hearing, please file a written submission setting out your views on the application with the Board and deliver it to the applicant no later than 14 days after the date this notice was served. If the applicant wishes to respond to the submission(s), the written response must be filed with the Board and delivered to all parties who made submissions no later than 21 days after the date this notice was served.
