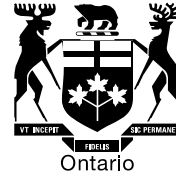

ERRATA SHEET

Please note the following revision to the Board's Decision and Order dated December 4, 2009:

- On page 9, the paragraph addressing the claim by the Salvation Army Centre of Hope is replaced with:

In response to Hydro One's comments with respect to some of the cost submissions, the Board confirms that the Salvation Army Centre of Hope's claim does not include amounts relating to alcohol. However, the Board has found it necessary to reduce the Salvation Army Centre of Hope's claim by \$35 due to a missing receipt and other discrepancies between amounts claimed and receipts provided. Subject to this reduction, the Board finds that the Salvation Army Centre of Hope is entitled to all of its other reasonably incurred costs of participating in this consultation process.
