1. On January 4, 2010 to immediately arrange for the enclosed French version of the Notice headed with the Ontario Government logo and the words “Commission de l’énergie de l’Ontario”, to be published in one issue of Le Droit and in one issue of the weekly French language newspaper having the highest circulation, according to the best information available, in or servicing Great Lakes Power Transmission LP’s service area;

On January 4, 2010, to immediately have the Notice served on:

- all licensed transmitters;
- the Independent Electricity System Operator;
- Ontario Power Authority

- the Association of Major Power Consumers of Ontario;
- Energy Probe;

3. To file with the Board an affidavit proving publication and service of the Notice immediately thereafter;
4. To make a copy of the two applications and related evidence for each available for public review at Great Lakes Power Transmission LP's office; and
5. To provide a copy of the relevant application and evidence to anyone requesting the material.
