The Board has now issued its Notice of Application and Hearing (the "Notice") with respect to the above noted application (the "Application").

You are directed:

- To immediately conduct a search of title forthwith, sufficient to determine the current registered property owners, encumbrancers and encumbrancees with land or an interest in land directly affected by the project;
- 2) To immediately serve a copy of the Notice, the location map and a copy of the Application, either personally, by courier, or by registered mail on:
  - a. All directly affected landowners, and to the extent that the project involves new, expanded or modified easements, on all encumbrancers and encumbrancees;
  - b. All owners and operators of rail lines, telecommunications (e.g. telephone) or other utilities along or crossing the routes proposed for the project;
  - c. All parties identified in the affidavit of title;

- d. Clerks of the Township of St. Clair, the Township of Dawn-Euphemia and the County of Lambton;
- e. All Aboriginal groups, including Native Bands and Reserves that could be affected by the project; and
- f. The following Provincial Government ministries and agencies:
  - Ministry of Energy and Infrastructure;
  - Ministry of the Environment;
  - Ministry of Aboriginal Affairs; and
  - Ministry of Transportation.
- g. All parties of record in EB-2008-0411.
- 4) To immediately have the Notice and location map, headed with the Ontario Government logo and the words "Ontario Energy Board", to be published in English in one issue of the local newspaper having, according to the best information available, the highest paid circulation, in the County of Lambton.

## Note A

Please make it clear to the newspaper(s) that the invoice regarding publication is to be sent to you, and not to the Board.

To file with the Board affidavit evidence proving the above service and publication immediately upon completion, with the relevant Notices, Application and location map, and original post office registration receipts (where applicable), or courier delivery confirmation lists attached as appendices.

## Note B

It is not necessary for the affidavits of publication to have newspaper tear sheets attached.

## Note C

The affidavits of service referred to above must confirm that the Municipal Clerks served are the clerks of <u>all</u> affected municipalities, that the Native Bands and Native Reserves served are <u>all</u> of the Bands and Reserves affected, that the utilities and railway companies served are <u>all</u> utilities and railway companies whose lines would be crossed by the proposed pipeline, and that the property owners and encumbrancers and encumbrancees so served are <u>all</u> owners and encumbrancers and encumbrancees affected by the proposed construction.
