Intervention of Energy Probe

Pursuant to the Board's Notice of Application and Hearing, dated November 27, 2009, Energy Probe Research Foundation (Energy Probe) is hereby providing Notice of Intervention in the EB-2009-0347 proceeding for the Board's consideration. An electronic version of Energy Probe's Notice will be provided in PDF format.

Energy Probe has become aware of a number of issues it wishes to pursue in this Matter, and has therefore availed itself of expert support. Based on our experience in past reviews of the Ontario Power Authority's (OPA) Expenditure, Revenue and Fees Submissions, it is the submission of Energy Probe that the public interest might best be served in this Matter through an Oral Hearing. It is the submission of Energy Probe that the Board should reserve it decision on further process until at least a round of interrogatories has been filed and responded to by the Applicant.

In the attached Notice of Intervention, Energy Probe requests one hard copy of OPA's prefiled evidence in addition to electronic copies.

The Board requested in the Notice of Application and Hearing that comments and/or additions to the Draft Issues List should be filed in conjunction with the filing of Notices of Intervention. Energy Probe has reviewed the December 4th submissions of the Vulnerable Energy Consumers Coalition (VECC) and with one notation, supports those submissions. Energy Probe notes that in VECC's proposal to add Issue No. 10, which Energy Probe supports, the Directive from the Minister of Energy and Infrastructure should refer to the date of *September 17, 2009*.
