**IN THE MATTER OF** the *Ontario Energy Board Act 1998*, S.O. 1998, c.15, (Schedule B);

**AND IN THE MATTER OF** an application by Enersource Hydro Mississauga Inc. for recovery of amounts related to Conservation and Demand Management activities.

#### PROCEDURAL ORDER NO. 1

Enersource Hydro Mississauga Inc. ("Enersource") has filed an application with the Ontario Energy Board, (the "Board") dated November 18, 2009 under the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15, Schedule B for an order granting approval and recovery of amounts related to new and ongoing Conservation and Demand Management ("CDM") activities in 2007 and 2008 associated with the Lost Revenue Adjustment Mechanism ("LRAM").

Notice of Application was served and published as directed by the Board.

As a result of the Notice of Application being published, the Vulnerable Energy Consumers Coalition ("VECC") and Direct Energy Marketing Limited ("Direct Energy") requested intervenor status. VECC requested eligibility for an award of costs. Subject to Energource's right to object, the Board grants the intervention request of Direct Energy and the intervention and costs eligibility request to VECC.

The Board has determined that it is necessary to make the following provisions related to this proceeding:

### THE BOARD ORDERS THAT:

- 1. Intervenors and Board Staff who wish information and material from the Applicant that is in addition to the evidence filed with the Board shall request it by written interrogatories filed with the Board, and delivered to the Applicant on or before, **Wednesday, January 20, 2010**.
- All interrogatories and responses must include a reference to the section of the application which identifies the specific evidence on which the interrogatory is based.
- 3. The Applicant shall file with the Board complete responses to the interrogatories and deliver them to the Intervenors no later than **Wednesday**, **January 27**, **2010**.
- 4. Any party that wishes to comment on Enersource's application or interrogatory responses shall do so by written submissions filed with the Board, and delivered to Enersource, on or before Wednesday, February 3, 2010.
- 5. Enersource may respond by written submission filed with the Board, and delivered to all parties, **on or before Wednesday, February 10, 2010**.
