**IN THE MATTER OF** the *Ontario Energy Board Act,* 1998, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application by Orangeville Hydro Limited for an order approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2010.

#### PROCEDURAL ORDER No. 3

Orangeville Hydro Limited (Orangeville Hydro) filed an application with the Ontario Energy Board, received on August 28, 2009 under section 78 of the *Ontario Energy Board Act*, 1998, seeking approval for changes to the rates that Orangeville Hydro charges for electricity distribution, to be effective May 1, 2010. The Board has assigned File Number EB-2009-0272 to this application. The Board issued a Notice of Application and Hearing on September 11, 2009, Procedural Order No. 1 on October 7, 2009, and Procedural Order No. 2 on November 18, 2009. An updated list of the intervenors in this proceeding is attached as Appendix A to this order.

Procedural Order No.2 provided for supplemental interrogatories. The Board indicated that it would determine the next steps through another procedural order.

With the supplemental interrogatories process now completed, the Board considers it necessary to make provision for the following procedural matters.

#### THE BOARD ORDERS THAT:

 A Settlement Conference will be convened on Monday, January 25, 2010, starting at 9:30 a.m. The Settlement Conference will be held at 2300 Yonge Street, Toronto in the Board's West Hearing Room on the 25th Floor. If necessary, the conference will continue on **Tuesday**, **January 26**, **2010**, in the Board's **ADR Room**.

 Any Settlement Proposal arising from the Settlement Conference shall be filed with the Board on Monday, February 8, 2010. In addition to outlining the terms of any settlement, the Settlement Proposal should contain a list of any unsettled issues.

Upon reviewing the Settlement Proposal the Board will determine the following steps. If necessary, the Board expects to consider any unsettled issues by means of an oral hearing, and a Procedural Order will be issued to that effect.

All filings to the Board must quote file number EB-2009-0272, be made through the Board's web portal at <a href="www.errr.oeb.gov.on.ca">www.errr.oeb.gov.on.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file seven paper copies. If you have submitted through the Board's web portal an e-mail is not required."
