**Re: EB-2008-0411 Union Gas Limited, Leave to sell St. Clair Line – Union's
Objections to Cost claim of Canadian Manufacturers & Exporters ("CME")**

Union Gas Limited ("Union") has reviewed the intervenor cost claims from CME. Union objects to the costs that relate to CME's involvement in Dawn Gateway LP's application to the National Energy Board ("NEB") for approval to construct and operate the Dawn Gateway Line and the costs claimed regarding preparation and finalizing e-mail correspondence with Mr. Aiken.

Mr. Thompson's Statement of Hours included time spent corresponding with the NEB in October 2009 regarding Dawn Gateway LP's NEB application. Union submits that any costs awarded by the OEB should only be in respect of Union's application for approval to sell the St. Clair Line, and that it is not appropriate for CME to claim costs from the OEB that relate to Dawn Gateway LP's NEB Application.

CME's cost s claim also includes time charges for an email from Mr. Thompson to Mr. Aiken. Union is unaware of Mr. Aiken's participation in or what contribution he may have made to the OEB proceeding.

Union requests that the Board review and adjust CME's cost claims as appropriate.
