**Re: Rawn v. Hydro One Networks Inc. (court file no. 442/07)**  
**Motion returnable Tuesday, Oct. 30, at 10 A.M.**

I refer to my phone conversation with you today.

I am writing to the Court on behalf of the Respondent, Hydro One Networks Inc. ("Hydro One") to advise that I will be attending on this motion tomorrow morning to request an adjournment. Hydro One was served with the very lengthy motion materials on Saturday and was served with a factum this morning. Hydro One needs a reasonable period of time to prepare responding materials.

I requested an adjournment this morning from Peter Fallis, counsel for the Moving Parties (Mr. and Mrs. Rawn), but he and I were unable to agree on the terms for the adjournment. Mr. Fallis has permitted me to advise the Court that although Hydro One was willing, as the term of the adjournment, not to enter onto the Rawn property pending the outcome of the Moving Parties' motion for a stay, Mr. Fallis required in addition that Hydro One also agree to an order incorporating, as terms of the adjournment, terms (b) through (i) on pages 17 and 18, Part V, paragraph 44, of the Moving Parties' factum served today. Hydro One was unwilling to agree to (b) through (i) as conditions for an adjournment to file responding materials.

I have spoken today with Michael Millar, counsel for the Ontario Energy Board, the tribunal whose decision is being appealed by the Moving Parties. Mr. Millar has advised me that he will be attending on behalf of the Ontario Energy Board to request an adjournment, as well.
