## **DECISION AND ORDER**

Boralex Inc. filed two applications with the Ontario Energy Board pursuant to section 74 of the *Ontario Energy Board Act, 1998*, for an order of the Board to amend five electricity generator licences under the Standard Offer Program. The licences are identified as follows:

- EG-2008-0126 2167308 Ontario Inc. as a general partner on behalf of Gracey Wind Farm Limited Partnership
- EG-2008-0127 2167308 Ontario Inc. as a general partner on behalf of Naylor Wind Farm Limited Partnership
- EG-2008-0125 2167308 Ontario Inc. as a general partner on behalf of North Malden Line Wind Farm Limited Partnership
- EG-2008-0123 2167308 Ontario Inc. as a general partner on behalf of Richardson Wind Farm Limited Partnership
- EG-2008-0124 2167308 Ontario Inc. as a general partner on behalf of South Side Wind Farm Limited Partnership

The Board assigned file numbers EB-2010-0011 through EB-2010-0015 to the licences respectively.

The applicant requested that "2167308 Ontario Inc. as general partner on behalf of" be deleted in each instance where it appears in the five aforementioned licences.

Boralex Ontario Energy Holdings 2 LP acquired or will acquire all of the partnership units of the five limited partnerships (collectively the "Limited Partnerships") on or before January 31, 2010. In conjunction with the acquisitions, the general partner of each of the Limited Partnerships will change from 2167308 Ontario Inc. to Boralex Wind Energy 2 Inc. There are no organizational changes in the licensee apart from the name change. The Limited Partnerships continue to be the beneficial holders of the licences.

I have proceeded to decide the application without a hearing pursuant to section 21(4)(b) of the Act since no other parties are adversely affected in a material way by the outcome of the proceeding and the applicant has requested that the matter be disposed of without a hearing.

I find that it is in the public interest to grant the requested amendment to the licence.

## IT IS THEREFORE ORDERED THAT:

Electricity Generator Licences EG-2008-0123, EG-2008-0124, EG-2008-0125, EG-2008-0126, and EG-2008-0127 are amended as requested. Specifically, "2167308 Ontario Inc. as a general partner on behalf of" has been deleted in each instance where it appears in the five licences.

The amended licences are attached to this Decision and Order.
