Notice of Intervention

Of

Tribute Resources Inc.

Take Notice That Tribute Resources Inc. ("Tribute") intends to intervene in the Hydro One Leave to Construct proceeding before the Ontario Energy Board ("Board") in order to participate selectively on limited issues that are relevant to its interests.

About Tribute

Tribute is a small publicly traded company listed on the TSX Venture, which is primarily engaged in the development of gas storage and renewable energy businesses. Tribute is actively engaged in drilling gas injection wells for its storage development, building pipelines and metering facilities and measuring wind resources and negotiating land leases with farm owners near the Lake Huron shoreline.

Tribute's Interest in the Hydro One s. 92 Application

Tribute is supportive of Hydro One's proposals to construct additional high voltage transmission facilities and reconfigure and modify various transmission stations. Tribute is primarily interested in Draft Issue 1.3 as Tribute believes that the Province of Ontario will require additional high voltage transmission facilities to bring new generation development to larger load centers, while relieving congestion in local areas as distributed (e.g. wind) generation is anticipated to grow.

Tribute's Participation

Tribute's counsel was instructed to seek intervener status when its Directors recently canvassed ongoing regulatory activities, following a recent Tribute Board meeting and a financial closing. Tribute does not believe that any party would be prejudiced or adversely affected if the Board grants intervener status to Tribute.

If granted intervener status, Tribute intends to review the record, periodically attend the proceedings with counsel in respect of the limited issues that are important to it, cross-examine if necessary, and submit final argument. Tribute will not be calling any witnesses to appear on its behalf.

Costs

Tribute will not be requesting any award of costs for its limited participation in the proceedings.
