On January 28, 2010 the Board issued its Board Staff Submission on Chapleau Public Utilities Corporation 2010 Electricity Distribution Rates Application Board File Number EB-2009-0219

On pages 6-8 of the Board Staff Submission for the "Adjustment to the Retail Transmission Rates (RTSR)" Board Staff asks Chapleau PUC to clarify if it wishes to continue with the as filed calculated RTSR adjustments, submit a revised calculation or reflect the January 1, 2010 UTR adjustments.

Response

Chapleau PUC will submit a revised calculation to reflect the January 1, 2010 UTR Adjustments.

Chapleau PUC is an embedded distributor to Hydro One Networks Inc. and pays for Transmission Network and Transmission Connection Charges to the IESO and Hydro One but does not pay for Transformation Connection Service.

Application for a revised Transmission Network Service Rate

To determine the increase for Transmission Network Service Rate it's necessary to determine what the combined increase is from the IESO and Hydro One.

As previously submitted, Chapleau PUC's actual kW charges for Transmission Network Service from September 2008 to August 2009 are as follows:
