construct a natural gas pipeline and ancillary facilities in  
the City of Windsor, in the County of Essex.

### **PROCEDURAL ORDER NO. 1**

Union Gas Limited ("Union" or "the Applicant") has filed an application with the Ontario Energy Board (the "Board"), received on August 14, 2007, under section 90(1) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B).

Union has applied for an order of the Board for leave to construct approximately five kilometers of 12 inch Nominal Size Pipe ("NPS") pipeline in the city of Windsor to meet the natural gas service requirement of the East Windsor Cogeneration Centre. The proposed facilities are located in the Township of Windsor, in the County of Windsor-Essex. The Board has assigned File No. EB-2007-0708 to this Application.

Notice of Application for the Leave to Construct Application was served and published as directed by the Board.

The Board has determined that it is necessary to make the following provisions related to this proceeding:

#### **THE BOARD ORDERS THAT:**

1. Intervenor and Board Staff who wish information and material from the Applicant that is in addition to the evidence filed with the Board shall request it by written

interrogatories filed with the Board, and delivered to the Applicant on or before, November 15, 2007.

2. All interrogatories and responses must include a reference to the section of the application which identifies the specific evidence on which the interrogatory is based.
3. The Applicant shall file with the Board complete responses to the interrogatories and deliver them to the Intervenors no later than November 24, 2007.
4. All filings must be filed with the Board Secretary, 2 hard copies and one electronic copy in searchable PDF format at [boardsec@gov.on.ca](mailto:boardsec@gov.on.ca) , by 4:00pm on the date indicated, and copy all parties.
