**Re: Veridian Connections Inc. - Gravenhurst  
Application for May 1<sup>st</sup> 2008 Electricity Distribution Rates and Charges**

We are pleased to submit the enclosed two copies of Veridian Connection Inc.'s application for May 1<sup>st</sup> 2008 electricity distribution rates and charges for its service territory in the Town of Gravenhurst, together with an electronic version of the same. The application has been developed using the Ontario Energy Board's 2008 IRM model.

An application for May 1<sup>st</sup> 2008 distribution rates for Veridian Connections Inc.'s licensed service territory outside of the Town of Gravenhurst is being filed under separate cover.

On October 29<sup>th</sup>, 2007 the Board Secretary issued notice to electricity distributors advising that 2008 IRM applications should include updates to retail transmission rates and disposition of associated variance account balances, as necessitated by an October 17<sup>th</sup> 2007 Board decision that established new wholesale transmission rates. The timing of this notice was inadequate to accommodate the filing of the enclosed application by the Board's target filing date of November 1<sup>st</sup>. We will file an addendum to this application as quickly as possible, to address the issue of retail transmission rates.


