We are writing on behalf of Kruger Energy Inc. ("KEI") in respect of the above-noted applications. We acknowledge, with thanks, your letter of April 8, 2010 in respect of these applications. The Ontario Energy Board is correct that Kruger Energy Port Alma Limited Partnership ("KEPA") is the licensed owner and operator of the Port Alma Windfarm pursuant to Electricity Generation Licence EG-2008-0027. Notwithstanding this fact, however, the actual day-to-day operator of the Port Alma Windfarm is KEI and not KEPA.

We are enclosing a copy of a letter from KEPA to the Ontario Energy Board, of today's date, requesting that its Electricity Generation Licence (EG-2008-0027) be amended to reflect the fact that while KEPA continues to own the Port Alma Windfarm, it is not the current operator of this facility and should not be licensed as such. In its letter, KEPA also acknowledges and supports KEI's application to be licensed as the operator of both the Port Alma Windfarm and the Kruger Energy Chatham ("KEC") Windfarm.

In light of the above and given the impending financing of the KEC Windfarm, KEI requests that the Board issue an <u>interim</u> Electricity Generation Licence, to KEI, authorizing it as the operator

of <u>both</u> the Port Alma Windfarm and the Kruger Energy Chatham Windfarm. Given the anticipated date of financial close, we respectfully request that such an interim authorization be issued by and be effective as of April 16, 2010.
