Re: EB-2010-0155; Union Gas Application for Certain Tariff Changes to M12, C1, and M16 Transportation Services in Order to Implement the Recently Issued Storage and Transportation Access Rule ("STAR")

The Ontario Energy Board issued Procedural Order #1 dated April 9, 2010 for the above noted proceeding. The Order notes that registered participants in the STAR (EB-2008-0052) proceeding are automatically registered as intervenors in this proceeding. APPrO was a registered intervenor in the STAR proceeding and also wishes to participate in this proceeding.

The Board has requested that intervenors wishing to seek cost eligibility status must separately apply to the Board. APPrO is hereby requesting cost eligibility status for this proceeding pursuant to the Board's Practice Direction on Cost Awards.

APPrO is a non-profit association that represents the interests of Ontario electricity generators in a number of settings, including regulatory proceedings. APPrO members represent more than 95% of Ontario's generating capacity in every generating technology: gas, wind, cogeneration, district heat and power, nuclear, hydroelectric, coal, solar, geothermal, energy from waste and fuel cells. APPrO's gas-fired generator members are major customers of Union Gas and contract for the above noted services and will be directly affected by the proposed changes.

APPrO has actively participated in a number of Ontario Energy Board gas-related proceedings. We believe that APPrO's participation in these proceedings has been responsible and has brought significant specific customer and public interest value to the Board in its deliberations.
