INTRODUCTION





SO WHY CAN'T WE PREPARE FOR MUCH BETTER AND CHEAPER BATTERY BREAKTHROUGHS?

- 17) EVERY PROBLEM of technical/technological nature that exists in every household and every industry in 2010 comes from our own self-invented capacities of PROBLEM INVENTION/PROBLEM CREATION. For every problem that we have invented for ourselves, we can invent ourselves out of the problem with a new invention. All that we need is a better plurality of working togetherness that has us ideas that we aren't use to listening to. listening to people and CHANGE THE BUSINESS LUNCHEON LIFESTYLE. CHANGE THE BUSINESS & LABOUR PODIUMS LIFESTYLES.
- 18) By bringing home-made energy into an affordable pricing mechanism, we will liberate transportable energies for some greater industrial projet utilisation. Shouldn't this be one of our market objectives?

I am asking the environmental energy constituency and industrial-energy leadership to come forth with some shared market-sector energy %. How much solar and wind energy could we expect for home & industrial areas by which years with what kind of along the way fiscal/monetary support?
