The applications will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. The employee does not intend to provide for an award of costs when deciding this application.

**How to participate in the hearing**

The applications will be decided by way of written hearings unless a party satisfies the Board that there is good reason for holding oral hearings. If you object to a written hearing for any of these applications, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant by May 10, 2010.

If you wish to participate in a written hearing, you must forward three paper copies, and if possible, an electronic copy in Word format and searchable PDF format, of your written submission on the applications, to the Board and one copy to the applicants. All submissions must be received by May 14, 2010. If the applicants wish to respond to the written submissions, such response must be filed with the Board and copied to any party that made submissions by May 21, 2010.

All submissions must quote file numbers EB-2010-0164, EB-2010-0165, EB-2010-0166 and EB-2010-0167 and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the
