I am writing on behalf of the Power Workers' Union ("PWU") in relation to the Board's invitation to comment in respect of the Board's proposal to amend the Affiliate Relationships Code for Electricity Distributors and Transmitters. I understand that the deadline for filing of comments with respect to the proposed amendments by interest parties was October 26, 2007.

The PWU has been an active participant in this proceeding, and has made submissions at every stage. The PWU intended to make comments with respect to the Board's proposed amendments in accordance with the Board's Notice of Proposal. The responsibility for the failure to meet the deadline for comments is mine; it arises largely as a result of a preoccupation with a number of other OEB proceedings which are presently ongoing.
