Pursuant to Hydro One Network Inc.'s (Hydro One) email received on May 19, 2010, Toronto Hydro-Electric System Limited (THESL) requests Intervenor Status in the EB-2010-0002 proceeding.

THESL is an electricity distributor operating under Licence ED-2002-0497. As an OEB-regulated utility, THESL has a direct interest in all matters of jurisdiction, substance and procedure with respect to the regulation of electricity in Ontario, and in decisions of the Board which may affect THESL's operation in the Ontario electricity market. In particular, as a customer of Hydro One, THESL will be affected by the Board's decision for changes to its transmission rates effective January 1, 2011. THESL was also a participant in the Hydro One Stakeholder Sessions on this matter held in March 2010.

THESL reserves the right to be heard, to appear by or with counsel of its choice, to cross-examine on all subject matters in this hearing that may relate to its interest, to advance evidence on specific matters that are relevant to this proceeding and to present argument.


