- 6. VECC has accessed the electronic version of the Application materials as filed on the OEB's web site. VECC requests that electronic copies of any additional supporting materials be forwarded to each of the two parties named above.
- 7. VECC is intervening in order to ensure that consumer interests and in particular the interests of the low-income and vulnerable users of electricity are fully represented in the costing and allocation of the Smart Meter Funding Adder. VECC's interests include:
 - a) the proposed increase in residential delivery charges of approximately 8.35%. This is a \$3.88 increase on the bill;
 - b) smart meter costs and the recording and attribution of costs to the Residential and GS<50kw classes.
 - VECC agrees with the Board's proposal to deal with the application by way of a written proceeding,

9. VECC will be requesting an award of costs for its participation in this proceeding and believes that, as a coalition representing the direct interests of consumers, it meets the eligibility criteria set out in the Ontario Energy Board's Rules of Practice and Procedure (Section 41) and its' Practice Direction on Cost Awards (Section 3.03).
