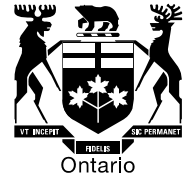

Re: Request for Information pursuant to s. 14.1 of Hydro One Networks Inc.'s Distribution Licence

The Minister of Energy and Infrastructure issued, with the approval of the Lieutenant Governor in Council, a directive to the Ontario Energy Board (the "Board") dated March 31, 2010, pursuant to sections 27.1 and 27.2 of the *Ontario Energy Board Act, 1998*. The directive requires the Board to amend the licence of each electricity distributor to add a condition requiring the distributor to achieve reductions in electricity consumption and reductions in peak provincial electricity demand through the delivery of conservation and demand management ("CDM") programs. The Board is required to have regard to information obtained by the Ontario Power Authority ("OPA"), developed in consultation with distributors, regarding the reductions in provincial peak electricity demand and electricity consumption that could be achieved by individual distributors through the delivery of CDM programs.

In establishing CDM targets for each distributor, the Board would be assisted by having hourly summer demand data (June to September inclusive) for all distributors for 2007, 2008 and 2009.

Hydro One Networks Inc. ("Hydro One") has the information that the Board requires for those distributors that have delivery points embedded within the Hydro One distribution system. The Board is therefore requiring Hydro One to provide the Board with the information set out below for the distributors set out below pursuant to section 14.1 of

Hydro One's distribution licence. Hydro One shall provide the following information to the Board:

Hourly demand data for summer months (June to September) for all embedded distributor delivery points, for the years 2007 through 2009.

The Board requires this information for all distributors with delivery points embedded within the Hydro One distribution system. The Board understands that the following distributors fall within this category, however the Board expects Hydro One to identify and provide data for any distributors which are missing from this list but which have embedded delivery points within the Hydro One distribution system.
