**NOTICE OF APPLICATION
AND PROCEDURAL ORDER No. 1**

On May 21, 2010, Enbridge Gas Distribution Inc. ("Enbridge") filed an updated application with the Ontario Energy Board (the "Board") seeking approval of certain demand side management ("DSM") input assumptions for its 2010 program year. The previous application was assigned file number EB-2009-0154.

The Board has assigned file number EB-2010-0202 to this application.

The Board's Decision with Reasons for the Natural Gas Demand Side Management Generic Proceeding (EB-2006-0021) outlined a process allowing for updates to the DSM input assumptions, "arising from the evaluation and audit process, to be filed with the Board and considered accordingly".

THE BOARD ORDERS THAT:

1. Enbridge shall immediately serve a copy of its application on each intervenor in the Demand Side Management Guidelines for Natural Gas Distributors Consultation (EB-2008-0346) and on each party currently involved in Enbridge's DSM Consultative (Full list attached as Appendix A).

2. Any party, including Board staff that wishes to comment on Enbridge's application shall do so by written submissions filed with the Board, and delivered to Enbridge, **on or before June 22, 2010.**
3. Enbridge may respond by written submissions filed with the Board, and delivered to all parties, **on or before July 7, 2010.**

All filings to the Board must quote the file number, EB-2010-0202, be made through the Board's web portal at www.errr.oeb.gov.on.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
