The Ontario Energy Board has received the following applications:

1. An Application for an Electricity Generator Licence by Kruger Energy Inc. – Board File Number EB- 2010-0151;
2. An Application for an Electricity Generator Licence by Kruger Energy Chatham Limited Partnership – Board File Number EB-2010-0203; and
3. An Application for an Electricity Generator Licence Amendment by Kruger Energy Port Alma Limited Partnership – Board File Number EB-2010-0169.

The granting of the requested electricity generator licences by Kruger Energy Inc. and Kruger Energy Chatham Limited Partnership would enable the applicants to generate electricity in Ontario.

Kruger Energy Port Alma Limited Partnership seeks to amend schedule 1 of its existing electricity generator licence EG-2008-0027 to:

- a. remove the operator qualification for the generation facility listed on schedule 1. If the electricity generator licence application of Kruger Energy Inc. is granted, Kruger Energy Inc. will operate the facility; and
- b. change the description of the generation facility to reflect a more specific municipal address.

The applications will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. The employee does not intend to provide for an award of costs when deciding these applications.

How to participate in the hearing

The applications will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing for these applications, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant(s) by June 28, 2010.

If you wish to participate in a written hearing, you must forward two paper copies, and if possible, an electronic copy in Word format and searchable PDF format, of your written submission to the Board and one copy to the applicant(s). All submissions must be received by July 2, 2010. If the applicant(s) wish to respond to the written submissions, such response must be filed with the Board and copied to any party that made submissions by July 9, 2010.

All submissions must quote the relevant file number, and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.

Information relating to the applications is available for viewing at the Board's offices at the address provided below or by contacting the applicants' counsel. The address and contact information for the applicants' counsel are also provided below.
