PROCEDURAL ORDER NO. 1

Union Gas Limited ("Union" or "the Applicant") has filed an application with the Ontario Energy Board (the "Board"), received on April 30, 2010, under the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B) for an order granting approval of its 2011 Natural Gas Demand Side Management ("DSM") Plan.

Notice of Application was served as directed by the Board.

As a result of the Notice of Application being served, the Industrial Gas Users Association ("IGUA") and the Vulnerable Energy Consumers Coalition ("VECC") requested intervenor status and requested eligibility for an award of costs. Enbridge Gas Distribution Inc. ("Enbridge") and the City of Kitchener requested intervenor status but will not be seeking an award of costs. Subject to Union's right to object, the Board grants the intervention requests and costs eligibility to IGUA and VECC and intervention requests to Enbridge and the City of Kitchener. Union has **seven (7) days** from the time of this Procedural Order being issued to object to any intervention requests.

The Board has determined that it is necessary to make the following provisions related to this proceeding:

THE BOARD ORDERS THAT:

1. Intervenors and Board Staff who seek additional information and material from the Applicant that is in addition to the evidence filed with the Board shall request it by written interrogatories filed with the Board, and delivered to the Applicant on or before, **Tuesday, July 6, 2010**.

All interrogatories and responses must include a reference to the section of the application which identifies the specific evidence on which the interrogatory is based.

2. The Applicant shall file with the Board complete responses to the interrogatories and deliver them to the intervenors no later than **Tuesday, July 20, 2010**.
3. Any party that wishes to make submissions on Union's application or interrogatory responses shall do so by written submissions filed with the Board, and delivered to Union, **on or before Wednesday, August 4, 2010**.
4. Union may respond by written submission filed with the Board, and delivered to all parties, **on or before Wednesday, August 11, 2010**.
