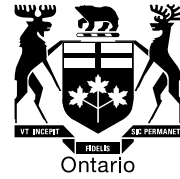

The Ontario Energy Board has now issued its Notice of Application (the "Notice") relating to your rate application. Please note that you must publish the Notice within fourteen days of the date of this letter. If publication is impossible within fourteen days, you must inform the Board Secretary immediately.

You are directed:

1. To arrange immediately for the enclosed English version of the Notice, headed with the Ontario government logo and the words "Ontario Energy Board", to be published in one issue of the English language newspaper having the highest paid circulation, according to the best information available, in PowerStream Hydro Inc.'s service area;

**(Note:** Please make it clear that invoices regarding publication are not to be sent to the Board.)

2. If PowerStream Inc. is a Host Distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);
3. To make a copy of the application and evidence, and any amendments thereto, available for public review at PowerStream Inc.'s office and on its website, if available; and,
4. To serve a copy of the Notice and the application directly on each party of record in the proceeding held to determine PowerStream Inc's 2009 electricity distribution rates (EB-2008-0244):
  - Vulnerable Energy Consumer's Coalition;
  - Association of Major Power Consumers In Ontario;
  - Consumers Council of Canada;
  - Energy Probe Research Foundation;
  - Hydro One Networks Inc.;
  - School Energy Coalition; and
  - Smart Sub-metering Working Group.
5. To file with the Board an affidavit proving publication and, where applicable, service of the Notice immediately thereafter.
6. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving this Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
