3. To file with the Board, both electronically and hard copy, an affidavit proving publication and, where applicable, service of the Notices immediately thereafter;
4. To make a copy of the application and evidence, and any amendments thereto, available for public review at Hydro One Brampton Networks Inc.'s office and on its website, if available; and,
5. To provide a copy of the application and evidence, and any amendments thereto, to each intervenor who participated in Hydro One Brampton Networks Inc.'s previous cost-of-service application (RP-2010-0020/EB-2005-0377), and to any other intervenor who requests a copy.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
