AND IN THE MATTER OF an Application by Enbridge Gas Distribution Inc. for an order or orders approving a system reliability Settlement Agreement.

PROCEDURAL ORDER NO. 1

Enbridge Gas Distribution Inc. ("Enbridge" or the "Company") filed an application, dated July 15, 2010 (the "Application"), with the Ontario Energy Board (the Board") under section 36 of the *Ontario Energy Board Act, S.O. 1998, c.15, Schedule B* (the "Act") for an order approving a system reliability Settlement Agreement and approving changes to rates in order to give effect to the provisions of the Settlement Agreement. The Board issued its Notice of Application on July 26, 2010 and formally assigned file number EB-2010-0231 to the Application.

The Intervention List appears as Appendix "A" to this procedural order.

The Board makes provision for the following procedural matters. Please be aware that further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

1. Parties seeking information and material on this Application shall request it by written interrogatories filed with the Board and delivered to all the parties no later than **August 9, 2010**.
2. Enbridge shall file complete responses to the interrogatories with the Board and deliver the responses to the other parties no later than **August 13, 2010**.

3. Parties wishing to make written submissions shall file such submissions with the Board and serve them on all parties by **August 18, 2010**.
4. Enbridge may file its Reply to any submissions by **August 20, 2010**.
5. All parties shall file their submissions with the Board Secretary and must quote File Number EB-2010-0231. These submissions should be made through the Board's web portal at www.errr.oeb.gov.on.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address, telephone number, fax number and e-mail address and must be sent to the Board by 4:45 pm on the date indicated with a copy to all parties. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may email your document to the Board Secretary at BoardSec@oeb.gov.on.ca. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
