PROCEDURAL ORDER NO. 4

Ontario Power Generation Inc. ("OPG" or the "Applicant") filed an application, dated May 26, 2010, with the Ontario Energy Board under section 78.1 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, Schedule B (the "Act") seeking approval for increases in payment amounts for the output of certain of its generating facilities, to be effective March 1, 2011.

On June 29, 2010, the Board issued Procedural Order No. 1 which set out a schedule for the proceeding, and which contained a draft issues list. Procedural Order No. 2, which was issued on July 5, 2010, amended the dates for parties to provide submissions on sections of the application for which OPG has requested confidential treatment. On July 21, 2010, the Board issued Decisions and Orders on Confidential Filings and Issues List, and Procedural Order No. 3.

In accordance with the procedural orders, OPG will file responses to interrogatories on August 12, 2010. The Board has reviewed the remaining schedule and is amending the schedule to allow Board staff and the parties to file questions in advance of the Technical Conference, and to move dates for other procedural steps correspondingly.

The Board considers it necessary to make provision for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

THE BOARD ORDERS THAT:

1. A transcribed Technical Conference will be convened on **Thursday, August 26, 2010** starting at 9:30 a.m. If necessary, the Technical Conference will continue on **Friday, August 27, 2010**, starting at 9:30 a.m. Parties participating in the Technical Conference are requested to file with the Board and copy OPG and all other parties, by **Thursday, August 19, 2010**, a list of issues and questions which they seek to address or upon which they intend to seek clarification at the Technical Conference.
