Notice of Motion by Integrated Grain Processors Co-operative Inc. and IGPC Ethanol Inc. ("IGPC") regarding the Capital Cost of the IGPC

Pipeline

Board File No.: EB-2006-0243

IGPC, in its Notice of Motion dated August 3, 2010 has made a request that the capital cost information regarding the pipeline built by NRG be filed in confidence. This information is contained in the attached sealed envelope. IGPC is bringing this motion and making the request for confidentiality as a precautionary measure.

The information provided at Tab 7 includes invoices from the various suppliers of materials, equipment and services to NRG purportedly for the purpose of building the pipeline. A list of the vendors and total amounts claimed is available at Tab 6 of the Notice of Motion. A further listing of the specific invoices including the date issued and amount was filed by NRG with the Ontario Energy Board as part of EB-2010-0018 in response to IGPC interrogatory I.R. #25.

These invoices contain the total cost and costing methodology used by the vendor in the transaction with NRG. Such information is the sensitive commercial information of the vendor and the release of such information, presumably, would have a detrimental impact on their business. However, this must be balanced against the need to ensure the public interest is fulfilled and that NRG is only recovering its permitted costs from a ratepayer, IGPC.

IGPC does not object to the information being provided in the public forum. However, such information may have been provided to NRG subject to certain confidentiality restrictions of which IGPC is unaware. IGPC does not wish to cause a breach of any such provision or subject such party to unnecessary scrutiny. IGPC would further note,

information has been provided to allow the Board to understand the costs claimed in regards to the pipeline, and the Board requires such documentation to be able to determine the pipelines Actual Capital Cost. However, IGPC is only contesting certain costs and has accepted the majority of costs as reasonable.

Further, IGPC would request the Board's direction on the proper service of the motion and the confidential materials. IGPC has provided a copy of the Notice of Motion including the confidential information in Tab 7 to NRG and to the Board. IGPC has provided a copy of the Notice of Motion excluding the confidential information to the Town of Aylmer ("Town"), the Vulnerable Energy Consumers Coalition ("VECC") and Union Gas Ltd. ("Union"). The Town, where the IGPC facility is located, has a franchise agreement with NRG and the Town and Union were participants in EB-2006-0243 the leave to construct proceeding and the current rate proceeding EB-2010-0018. VECC is a participant in the EB-2010-0018 only.

IGPC has not served either the Municipality of the Thames Centre or the County of Middlesex and would specifically request the Board indicate whether service is required. The Municipality of Thames Centre and the County of Middlesex participated in EB-2006-0243 but have not participated in EB-2010-0018 nor have either municipality participated in NRG's recent rate proceedings. As the Notice of Motion deals with financial matters between NRG and IGPC and will inform the proper setting of rates IGPC is uncertain as to the interest or perspective that such groups would provide that are not already represented.

IGPC realizes this is a unique situation and appreciates the Board's and the third parties' role in this matter.
