Re: EB-2010-0008 – Ontario Power Generation Inc. Payment Amounts for **Prescribed Facilities** 

In Procedural Order No.3, the Ontario Energy Board (OEB) approved Ontario Power Generation Inc.'s (OPG) request for confidential treatment of certain tax information (the "Tax Information"), redactions in 34 business case summaries (BCSs), including the Niagara Tunnel Project and Darlington Refurbishment BCSs, and certain redactions within the Nuclear Business Plans and the Hydroelectric Business Plan. All of the information ordered to be treated as confidential pursuant to Procedural Order No. 3 is referred to as Confidential Information.

In Procedural Order No. 3, the OEB provided that parties make every attempt to frame interrogatories on the confidential material such that the interrogatories can be filed on the public record. OPG received the OEB Staff's interrogatories on July 22, 2010 and interrogatories from intervenors on or about July 29, 2010. The following interrogatory responses (the "Responses") include Confidential Information:

The Responses will be disclosed, subject to any conditions the OEB may find appropriate, to only those persons that filed the Declaration and Undertaking referenced in Procedural Order No 1. Non-confidential versions of the responses will be filed on the public record. At the conclusion of the proceeding, all persons in

possession of the Responses will be required to destroy or return to the OEB Secretary for destruction the Responses in accordance with 6.1.6 of the Practice Direction.

In addition, OPG requests that any reference to the Responses will be conducted *in camera* so as to preserve their confidential nature.
