Brant County Power Inc. ("BCPI") Review Motion – Ontario Energy Board Order for Brantford Power Inc. 2008 Electricity Distribution Rates and Charges

We are counsel to Brantford Power Inc. ("BPI") with respect to the above-captioned matter. Pursuant to the Board's August 10, 2010 Decision and Order in this matter, please find accompanying this letter a draft revised Tariff of Rates and Charges reflecting BPI's distribution rates and retail transmission service rates for Brant County Power ("BCP") for 2008, 2009 and 2010 (see pages 4 and 5 of the document). These rates are consistent with BPI's submission of August 20, 2010.

At this time, BPI also wishes to clarify one statement made in its submission of August 20th. Paragraph 5(c) of the submission states:

(c) The starting point for the calculation of rates is a revenue in the amount of \$348,973.46 decreased from \$425,868.60. The \$348,793.46 revenue starting point results in a revenue reduction of \$76,895.14 to be recovered from BCP.

To be clear, BPI confirms that the starting point for the calculation of a distribution rate for BCP is revenue in the amount of \$348,973.46, and that this represents a reduction of \$76,895.14 from the \$425,868.60 in revenue previously assigned to BCP. BPI is not recovering that difference of \$76,895.14 directly from BCP – the BPI rates have been designed to recover the \$348,973.46, subject to annual adjustments. Any under-recovery by BPI as a result of the new BCP rate being less than the rate previously applied to BCP will be tracked in a variance account for recovery at BPI's next rebasing, in accordance with paragraph 50 of the Board's August 10, 2010 Decision and as addressed at paragraph 22 of BPI's August 20, 2010 submission. I have discussed this clarification with counsel to BCP and we agree that it represents the understanding of both parties with respect to the treatment of the \$76,895.14 reduction.
