Re: Hydro One Networks Inc. ("HONI") - 2011 & 2012 Transmission Revenue Requirement Application (EB-2010-0002) - Letter of Intervention by Brookfield Energy Marketing Inc.

We are counsel to Brookfield Energy Marketing Inc. ("BEMI"). On behalf of BEMI, we are writing to request late intervenor status in the above-referenced proceeding pursuant to Rule 23.05 of the Ontario Energy Board's (the "Board") Rules of Practice and Procedure. BEMI requests that this letter be considered its notice of motion in this regard.

BEMI is an Ontario energy market participant that sells and buys energy in Ontario and on an interjurisdictional basis. As such, BEMI has an interest in this proceeding. In particular, BEMI is interested aspects related to the export transmission service tariff that will be considered as part of Issue 1.1 on the Board's approved issues list. With respect to the reasons for its late intervention request, BEMI notes that the Board's decision confirming the aforementioned issue as part of the approved issue list only recently came to BEMI's attention.

BEMI does not intend to request a cost award. BEMI will accept the record in and the timelines for this proceeding as they stand. BEMI does not intend to submit evidence in this proceeding. However, given the scheduled date of September 3, 2010 for submitting interrogatories in respect of evidence submitted by intervenors on August 26, 2010, BEMI requests that it be permitted to proceed on the basis that it will be granted intervenor status in order that it may meet the applicable deadline.
