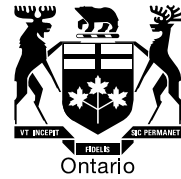

The Board has reviewed your application for an electricity wholesaler licence. Your application is currently incomplete and cannot be processed until the following has been filed:

**1. Section 2 of the Application Form for an Electricity Wholesaler Licence –  
Licence Primary Contact**

As indicated on page 2 of the application form, if the address of the licence primary contact is not in Ontario, the applicant must provide contact information for service purposes in the province of Ontario. In your application, the address provided for the licence primary contact is not in Ontario and no address in Ontario is provided for service purposes.

To meet the requirements of the above section, you may provide the address of an agent (an individual who is a resident of Ontario and is at least 18 years old, or a corporation that has its head office or registered office in Ontario) as the address of service.

**2. Section 9 of the Application Form for an Electricity Wholesaler Licence –  
Licence – Finance**

The financial information provided with your application does not meet the requirements of section 9 of the application form. Please file the relevant information requested in section 9 of the application form. Specifically, you may file:

- a) financial statements for the last two years for the applicant (i.e. GDF SUEZ Energy Marketing NA, Inc.) or its parent company, along with a parental guarantee, or at least two of the following items:
- i. GDF SUEZ Energy Marketing NA, Inc.'s most recent prospectus and quarterly report;
  - ii. Letter of reference from the GDF SUEZ Energy Marketing NA, Inc.'s bank;
  - iii. Other information demonstrating GDF SUEZ Energy Marketing NA, Inc.'s financial status.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue a letter indicating the expected date on which a decision and/or order may be rendered.
