4. To inform the Board by way of letter directed to the Board Secretary that the notices have been posted on your website, immediately upon completion.
5. To file with the Board evidence proving the above service immediately upon completion, with original post office registration receipts (where applicable), or courier confirmation lists attached as appendices.
6. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.
