NOTICE OF APPLICATION AND WRITTEN HEARING

Electricity Retailer Licence Renewal Application Gas Marketer Licence Renewal Application

Energhx Green Energy Corporation, doing business as Energhx Consulting ("Energhx"), filed an application with the Ontario Energy Board (the "Board") dated July 8, 2010, under section 60 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B) (the "Act") for a renewal of its electricity retailer licence. The granting of this licence would enable the applicant to continue to retail electricity in Ontario. The Board has assigned the application file number EB-2010-0236.

Energhx also filed an application under section 50 of the Act to renew its gas marketer licence. The granting of this licence would enable the applicant to continue to market natural gas in Ontario. The Board has assigned the application file number EB-2010-0237.

The applications will be decided by the Counsel, Special Projects, who has been delegated this authority pursuant to section 6 of the Act. The Counsel, Special Projects, does not intend to provide for an award of costs when deciding this application.

Copies of the applications are available for inspection at the Board's office in Toronto and at Energhx's office and may be posted on its website.

How to Participate in the Hearing

The applications will be decided by way of written hearing unless a party satisfies the Board that there is good reason for holding an oral hearing. If you object to a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any objections to a written hearing must be received by the Board and copied to the applicant within **10 days** from the date that this notice is issued.

If you wish to participate in the written hearing, please file a written submission setting out your views on the application. You must forward three paper copies, and if possible, an electronic copy in Word format and in searchable PDF format, of your submission to the Board and one copy to the applicant at the addresses below. All submissions must be received no later than **14 days** after the date that this notice is issued.

If Board staff wish to file a written submission, the written submission must be filed with the Board and delivered to the applicant no later than **21 days** after the date that this notice is issued.

If Energhx wishes to respond to the submissions, such response must be filed with the Board and copied to any party that made submissions no later than **28 days** after the date that this notice is issued.

All submissions must quote file numbers EB-2010-0236 and EB-2010-0237, and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
