Re: 2010 Natural Gas Market Review – Question and Answer Session on the ICF Market Report (EB-2010-0199)

The Ontario Energy Board has initiated a review and examination of recent developments in North American natural gas supply markets to consider any potential implications for the Ontario natural gas market. On July 13, 2010, the Board issued a letter describing the Board process for the 2010 Natural Gas Market Review (the “Review”).

On August 20, 2010 the Board posted to its website a report prepared by ICF International Inc. (“ICF”) entitled “2010 Natural Gas Market Review” (the “ICF Market Report”). Participants in the consultation are invited to attend a question and answer session with the authors of the report as follows:
