

IN THE MATTER OF the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B);

AND IN THE MATTER OF an application by Enbridge Gas Distribution Inc. for an order or orders approving the balance and clearance of the Class Action Suit Deferral Account;

AND IN THE MATTER OF an application by Enbridge Gas Distribution Inc. for an order or orders amending or varying the rates charged to customers for the sale, distribution, transmission and storage of gas commencing January 1, 2008.

PROCEDURAL ORDER NO.1

Enbridge Gas Distribution Inc. ("Enbridge") filed an Application dated September 28, 2007 (the "Application") with the Ontario Energy Board (the "Board") under section 36 of the *Ontario Energy Board Act, 1998*, S.O. c.15, Sched. B, as amended, for an order of the Board approving the final balance in the 2007 Class Action Suit Deferral Account ("CASDA") and the disposition of that balance.

The Board has assigned the application file number EB-2007-0731. The Board issued a Notice of Application and Hearing dated October 26, 2007.

The Board has decided to proceed by way of written hearing, and considers it necessary to make provision for the procedural matters set out below. The Board may proceed by way of an oral hearing at a future date, if it determines an oral hearing will further assist the Board in its deliberation of these matters. Please be aware that this procedural order may be amended, and further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

- Parties who wish information and material from the applicant that is in addition to the evidence filed with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the applicant on or before December 7, 2007. A list of intervenors is attached as Appendix A to this order.
- 2. The applicant shall file with the Board complete responses to the interrogatories and deliver them to the intervenors no later than December 17, 2007.
- 3. Intervenors must file their arguments with the Board and deliver same to the applicant and other intervenors by January 11, 2008. Board staff shall file and deliver any submission on the application by January 8, 2008.
- 4. The applicant may reply to any arguments and submissions by January 23, 2008.

All filings to the Board must quote file number EB-2007-0731, be made through the Board's web portal at www.errr.oeb.gov.on.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
