6. VECC has accessed the Application as filed on the OEB's web site. VECC requests that copies of any additional supporting materials be forwarded to each of the two parties named above.
7. VECC is intervening in order to ensure that consumer interests and in particular the interests of the low-income and vulnerable users of electricity are fully represented in the determination of just and reasonable rates for 2011. Areas of the current Application of interest to VECC include: a) the 35% deficiency relative to current distribution revenues; b) the increase in OM&A costs between 2009 and 2011 of over 28%, c) the load forecast methodology and results, d) the cost of debt, e) the allocation of costs to customer classes and e) the proposals for new deferral/variance accounts, f) the allocation of affiliate costs, g) the requested LRAM/SSM and h) the proposed rate design.

8. VECC agrees with the Board's proposal to deal with the application by way of a written proceeding, with the provision for an oral component if required. In VECC's view, the decision regarding the need for an oral component is best made after the completion of the interrogatory process.
9. VECC will be requesting an award of costs for its participation in this proceeding and believes that, as a coalition representing the direct interests of consumers, it meets the eligibility criteria set out in the Ontario Energy Board's Rules of Practice and Procedure (Section 41) and its' Practice Direction on Cost Awards (Section 3.03).
