AND IN THE MATTER OF an application by Hydro One Networks Inc. for an order approving joint use rates for generator use of distribution poles and fees for Connection Impact Assessments

PROCEDURAL ORDER NO. 2

Hydro One Networks Inc. ("Hydro One") filed an application with the Ontario Energy Board, received on June 30, 2010, under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15 (Schedule B), requesting approval of new Joint Use charges related to generation projects, to be effective January 1, 2010, and new and revised fees for a Connection Impact Assessment ("CIA"). Hydro One has requested that the proposed CIA fees be declared interim until the final Decision and Order in this proceeding. The Board has assigned the application File Number EB-2010-0228.

The Board issued a Notice of Application and Hearing dated July 22, 2010.

The Board issued Procedural Order No. 1 on August 18, 2010 approving intervenors and setting filing dates for interrogatories, interrogatory responses, and any additional evidence.

The Board now considers it necessary to set dates for a technical conference, which will be limited to clarifying the interrogatory responses, and to set dates for the argument-inchief, Board staff submission, intervenor arguments, and reply argument. To facilitate the Technical Conference, written questions are to be submitted in advance in order for Hydro One to prepare effective responses.

THE BOARD ORDERS THAT:

- 1. Parties wishing clarification or additional information in regards to the interrogatory responses are to deliver to the Applicant and file with the Board any written questions by Friday October 8, 2010.
- 2. A Technical Conference will be convened at the Board's offices at 2300 Yonge Street, 25th floor starting at 9:00 am on Monday October 18, 2010.
- 3. Hydro One Distribution Inc. is to file its Argument-in-Chief with the Board and deliver it to the intervenors by Monday October 25, 2010.
- 4. Board staff is to file its submission with the Board and deliver it to the Applicant and intervenors by Friday October 29, 2010 and intervenors wishing to make a submission are to file submission with the Board and deliver to the Applicant and other intervenors by Monday November 1, 2010.
- 5. Hydro One is to file any Reply Submission with the Board and deliver it to the intervenors by Monday November 8, 2010

All filings to the Board must quote file number EB-2010-0228, be made through the Board's web portal at www.errr.oeb.gov.on.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address, telephone number, fax number, and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may email your document to the BoardSec@oeb.gov.on.ca. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file seven paper copies. If you have submitted through the Board's web portal an e-mail is not required."
