Re: Hydro One Networks Inc. ("HONI") - Application for Amendment to Electricity Distribution License (EB-2010-0229) - Letter of Intervention by International Power Canada, Inc.

We are counsel to International Power Canada, Inc. ("IPC"). On behalf of IPC, we are writing to request late intervenor status in the above-referenced proceeding pursuant to Rule 23.05 of the Ontario Energy Board's (the "Board's") Rules of Practice and Procedure. IPC requests that this letter be considered its notice of motion in this regard.

IPC is a developer, owner and operator of Ontario-based generation and distribution facilities, among other things. As such, IPC has an interest in this proceeding. In particular, IPC is interested in all aspects of the proceeding that may affect the timing of the connection of large generators embedded within HONI distribution systems and the cost of distribution system upgrades borne by these generators. With respect to the reasons for its late intervention request, IPC notes that the potential impact of the HONI proceeding on the aforementioned issues only recently came to IPC's attention.

IPC does not intend to request a cost award or to submit evidence in this proceeding. IPC will accept the record in and the timelines for this proceeding as they stand.
