**Re: Intervenor Status and Cost Eligibility Request on Behalf of the Ontario Sustainable Energy Association, EB-2010-0228**

By way of letter dated October 6, 2010 the Ontario Sustainable Energy Association ("OSEA") requested late intervention status and cost eligibility in the Application of Hydro One Networks Inc. EB-2010-0228. The Board has considered the late intervention request of the OSEA and has granted the request to intervene and for cost eligibility. The Board also has determined that if the OSEA wishes clarification or additional information in regards to the interrogatory responses already provided by the Applicant, it is to deliver to the Applicant and file with the Board written questions by Tuesday October 12, 2010.

Filings must clearly state the sender's name, postal address, telephone number, fax number, and e-mail address. The OESA must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.oeb.gov.on.ca](http://www.oeb.gov.on.ca). If the web portal is not available the OESA may email documents to the [BoardSec@oeb.gov.on.ca](mailto:BoardSec@oeb.gov.on.ca). If the OESA does not have internet access it is required to

submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file seven paper copies. If the OESC has submitted through the Board's web portal an e-mail is not required.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
