Re: Thunder Bay Hydro Electricity Distribution Inc. - Application for Exemption from Mandated Time-of-Use Pricing Determination Date

On June 24, 2010, the Ontario Energy Board ("OEB" or "Board") issued a proposed determination Under Section 1.2.1 of the Standard Supply Service Code ("SSSC") to mandate Time-of-Use ("TOU") pricing for RPP consumers.

On August 4, 2010 the Board issued its final determination to Mandate TOU pricing for RPP consumers by establishing the mandatory TOU date for each electricity distributor. Given the mandatory TOU date of June of 2011, Thunder Bay Hydro Electricity Distribution Inc. (TBHEDI) is requesting an exemption from this date and a new date of August 2011.

The Board acknowledges in EB-2010-0218 that:

distributors may encounter extraordinary and unanticipated circumstances during the implementation of TOU pricing. The Board requests that any distributor encountering such circumstances bring these matters to the Board's attention without delay in order that the Board can assess the impact on the distributor's mandatory TOU date and assess whether any adjustment in that date is warranted.

The crux of the issue with the determination date is that TBHEDI is working with four other utilities in Northern Ontario on all aspects of the smart metering project and due to this cooperative approach; TBHEDI cannot meet its mandatory date. The mandatory TOU determination date set by the OEB is two months prior to TBHEDI's project plan cutover date with the MDM/R. TBHEDI is currently engaged in Unit testing with the IESO to prepare Sioux Lookout Hydro, Atikokan Hydro, Fort Frances Power Corp and Kenora Hydro for the upcoming SIT and QT testing. The original project plan with the IESO had to be rescheduled due to technical testing delays that occurred during the summer months. Subsequently, the project plans had to be re-filed and they have now been confirmed by the IESO.

TBHEDI has chosen to lead this group approach. In order to provide a fiscally responsible solution to the rate payers of each member utility, TBHEDI will continue to strive toward finishing the testing early and meeting the determination date (June 2011) as set by the OEB. However, TBHEDI believes that the responsible and realistic response is to align the determination date with the confirmed IESO enrolment wave notices as attached.






